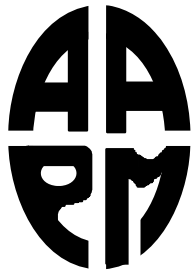

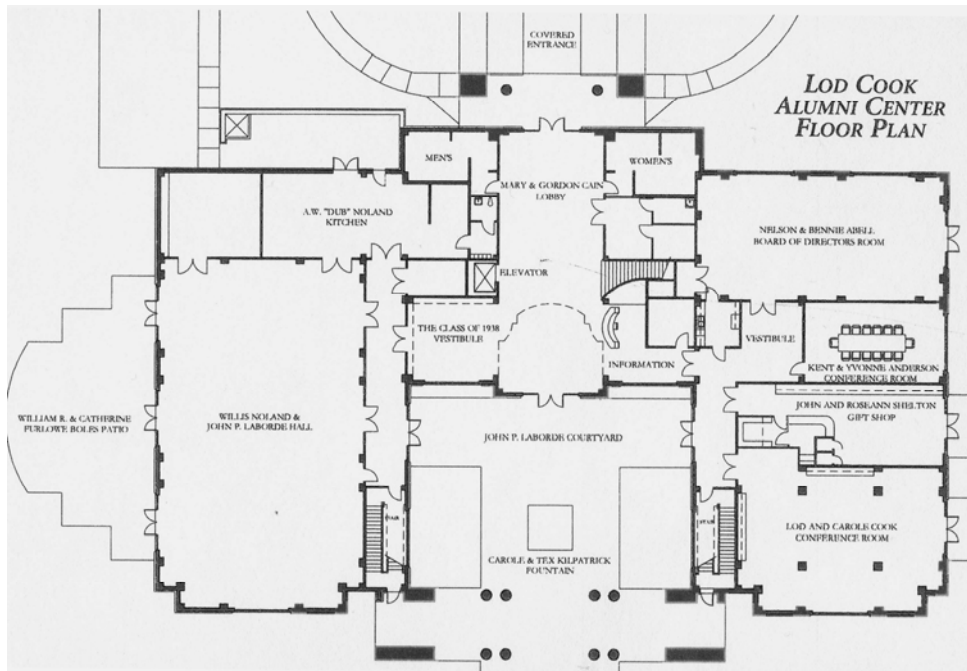
EXHIBITOR AREA INFORMATION

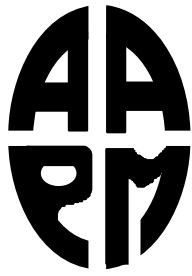
